#### **Membership Access**

The Gym is available for use by all current existing Gold, Silver, Bronze members and staff.

No person under the age of 18 years old is permitted in the gym.

The Gym is located in the Yarra Room and operates from 8:30am to 8:30pm daily.

#### **Conduct and Behaviour**

Management reserves the right to refuse entry, cancel a membership or request a member to leave the premises if the member does not behave in a responsible manner, is under the influence of drugs and/or alcohol or does not adhere to the terms and conditions.

Smoking and eating food is not permitted in the Gym.

#### **Use of Gym**

Members are responsible for monitoring their own physical condition and health.

All members acknowledge that they are in sufficient physical condition to use the Gym and equipment.

#### **Equipment**

All equipment must be handled appropriately and returned after use.

Use of the Gym equipment is on the basis that the member has an understanding of the proper use of such equipment and uses that equipment at their own risk.

Any faults or damage must be reported to Management as soon as possible.

#### **Supervision**

At times the Gym may be unattended. The unsupervised facility is used at members own risk.

Members should familiarize themselves fully in the operation of the equipment provided and workout within their limitations.
